DMIRS Occupational Licensing Performance Report

- March Quarter 2022

The Department of Mines, Industry Regulation and Safety (DMIRS) administers over one hundred diverse and complex licence types. These cover the majority of Western Australia's occupational licensing and involve a large number of differing legislative requirements, interpretations and administrative requirements.

Maintaining public confidence and safety in regulated industries is critical and it is important that DMIRS makes high quality decisions consistently and in accordance with legislated requirements. However DMIRS also understands that occupational licences enable and support the State's economy and the people within it. Whether a decision is for a large company or project or someone just starting out in a new industry or profession, timeliness and transparency is critical.

DMIRS commenced publication of licensing performance reports in 2021 and until now these have provided only the average number of days taken to finalise new applications and renewals. However as part of our commitment to transparency and being open and accountable in what we do, DMIRS has developed a new dashboard format for 2022 that provides more detailed information. The report now features:

- Performance against targets within the quarter.
- Performance over time which provides more context to quarterly performance.
- A breakdown of the total timeline which shows the parties involved in each decision.

For this report we have kept it simple by grouping multiple licence types into licence categories that share similar characteristics, taking into consideration the various levels of application complexity. The final page of the quarterly report provides a list of licence types and groupings.

The DMIRS performance target is to finalise 80 per cent of applications within the target timeline. The timeline targets are administrative and are intended to reflect the complexity of each application and our understanding of individual and industry need.

Factors influencing assessment timelines can include whether:

- All of the required information is provided by an applicant. If it isn't, this requires follow-up with applicants which adds time and can be confronting for applicants where the additional information required is focused on their professional experience.
- Advice or review from other agencies, statutory boards or Commissioners is required.


DMIRS is continuing to work on strategies to improve licensing performance and the customer experience through a range of initiatives across 2022. These include:


- Expanding online lodgement and fee payment across the remaining paper-based applications.










Registered Painting Contractor and Practitioner










Registered Building Surveyor and Owner Builder










Gas Licensing
