



Approvals Performance Report – Third Quarter 2009

The Department of Mines and Petroleum is pleased to present the third quarterly report on its approvals performance. The results show generally positive trends against key approval target timelines.

In particular, mining proposal environmental assessments improved from 68 per cent completed within 30 business days in the second quarter to 76 per cent in the third quarter. The number of pending mining tenure applications is also continuing its downward trend, now standing at a total of 8698, albeit at a slower rate in comparison to that seen in the second quarter.

Mixed results, however, were produced in relation to petroleum and geothermal tenure applications. The results reflect resourcing during this quarter being focused on reducing the number of pending tenements for licences and permits.

The results also show that the level of activity in relation to minerals exploration has increased in recent months, with continuing high numbers of applications received for Programmes of Work and Exploration Licences.

Continual enhancements to the Department's information management systems are seen as the key to delivering substantial improvements in the efficiency of processes for mining and petroleum applications. The current priority is to deliver planned improvements which will allow for the online lodgement of applications and proposals, and expanding the provision of online payments.

In recent months the Department has been working with industry to enable electronic lodgement for Programmes of Work and petroleum pipeline applications. This facility is expected to be made available to industry by November this year and will be a major step towards automating the receipt and assessment of applications.

While electronic tracking is now in place for all the key approvals, further improvements planned for the coming months will result in greater levels of transparency for the Department's approval processes. This supports the recommendation of the Auditor General's report *Improving Resource Project Approvals* (October 2008) for agencies to use data and management systems more effectively to manage approval processes.

Explanatory notes:

- 1 Applications "otherwise dealt with" include those that have been refused, lapsed, rejected or withdrawn.
- 2 All approvals timelines under are subject to the 'Stop the Clock' mechanism, whereby the timeline target is adjusted to not include the time taken by processes outside DMP's control, such as referrals to other government agencies, during a prescribed public comment period or where additional information has been requested from applicants.

- 4 Some discrepancies between the number of applications carried over to the next quarter may occur due to ongoing auditing of pending applications.
