PROPOSED AMENDMENTS TO THE GUIDELINES FOR MINERAL EXPLORATION REPORTS ON MINING TENEMENTS

April 2019

Introduction

Minor amendments to the Guidelines for Mineral Exploration Reports on Mining Tenements were proposed. Following a period of consultation the Guidelines will now proceed to gazettal.

Consultation

The proposed amendments were released for public comment and a number of individuals, companies and industry bodies provided feedback.

Overall, the feedback was positive. The majority of concerns raised were with amendments gazetted in the previous version, with wording taken directly from the Mining Act or Mining Regulations and also with the formatting of reports produced using the DMIRS online wizard; none of which were the subject of the current proposed amendments.

DMIRS would like to thank all stakeholders for their considered feedback.
